This Addendum forms part of the above mention Tender document and is to be read, interpreted, and coordinated with all other parts. The following revisions supersede the information contained in the original Tender documents issued for the above-named service to the extent referenced and shall become part thereof.

The following information supplements and/or supersedes the Tender Document issued on November 9 2021.

#### 1. Questions and Answers

Q1. On Page 20, Under schedule of Prices, it says the contract term is January 1, 2022 to December 31, 2021 – should this be December 31, 2023?

A1. That is correct the contract term is January 1, 2022 to December 31, 2023.

Q2. The document mentions that there is the possibility of a one-year extension beginning on Jan 1, 2024, however it does not indicate whether it's the decision of the Township, or if it's by mutual consent?

A2. The one-year extension will be the decision of the Township.

Q3. The Clause that indicates "The contractor acknowledges and agrees the price for the work includes any inflation or escalation for duration of the specified Contract time. No additional compensation will be considered." There is not anywhere that we can put a different price in for year 2 of the contract, so does this mean that the price is flat for the 2 years plus the option year?

A3. The schedule of prices will be amended to include year two (2) and a provisional item for year three (3) (optional one year extension).
