## Notice of Complete Application and Public Meeting Concerning a Proposed Zoning By-Law Amendment

**Take notice** that the Corporation of the Township of Asphodel-Norwood hereby considers an application to amend Zoning By-Law 2009-08 under Section 34 of the Planning Act, as described below in the Purpose and Effect, to be a Complete Application in accordance with Section 34(10.7) of the Planning Act. The application has been assigned file number ZBLA-01-2024.

### Location

A Key Map is attached which indicates the location of the lands which are subject to the application. The lands are located at Concession 10, Part Lot 17 in the Township of Asphodel-Norwood and known as 2319 Asphodel 10<sup>TH</sup> Line.

**The purpose and effect** of the Zoning By-Law Amendment is to re-zone a portion of the subject lands from the Rural (RU) Zone to the Rural Residential (RR) Zone. The rezoning is required as a condition of consent for Peterborough County Land Division Files B-46-23 and B-47-23. The effect is to create two new residential lots. There is no change to the remaining existing Rural (RU) Zone and no change to the Environmental Protection (EP) Zone.

### Statutory Public Meeting Information

The Council of the Corporation of the Township of Asphodel-Norwood will hold a Public Meeting under Section 34 of the Planning Act. You are invited to attend the Statutory Public Meeting to consider the proposed amendment. This meeting will take place on:

### The Right to Appeal

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Asphodel-Norwood before the by-law is passed, the person or public body is not entitled to appeal the decision of the Township of Asphodel-Norwood to the Ontario Land Tribunal.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Asphodel-Norwood before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

**If you wish to be notified** of the decision for any application, you must make a written request to the Township of Asphodel-Norwood at the address noted below and quote the appropriate file number ZBLA-01-2024.

The purpose and effect of the Zoning By-Law Amendment is to re-zone a portion of the subject lands from the Rural (RU) Zone to the Rural Residential (RR) Zone. The rezoning is required as a condition of consent for Peterborough County Land Division Files B-46-23 and B-47-23. The effect is to create two new residential lots. There is no change to the remaining existing Rural (RU) Zone or the Environmental Protection (EP) Zone.

The severed parcel described as Lot 1 has a lot area of 0.46 hectares (1.14 acres) and a lot frontage of 60 metres (200 feet) on Asphodel 10<sup>TH</sup> Line. The severed parcel described as Lot 2 has a lot area of 0.46 hectares (1.14 acres) and a lot frontage of 60 metres (200 feet) on Asphodel 10<sup>TH</sup> Line.

The Amendment is applicable to lands located in Part Lot 17, Concession 10, Asphodel Ward, known municipally as 2319 Asphodel 10<sup>TH</sup> Line, and as shown on the key map below.
