Thank you to Council for providing the space at no cost, and to the dedicated volunteers and community partners whose generosity and support make this annual event possible.





## SENIOR OF THE YEAR

**Robert Gordon**



At its October 21, 2025 meeting, Council recognized Mr. Robert Gordon as a recipient of the 2025 Ontario Senior of the Year Award.

Mr. Gordon is a long-standing member of the Asphodel-Norwood Historical Society and an active volunteer with the Township's Cultural & Heritage Committee. His many community contributions include being a former long-time member of the Donegal Fiddlers, a dedicated volunteer with the Norwood Fair's art section, and the creative force behind the popular Scarecrow Challenge.

He is also a Life Member of the Royal Canadian Legion Branch 300, where he curated and continues to promote the Military Museum. Professionally, Mr. Gordon has enjoyed an accomplished career as a photographer and is the author of three local history books, with a fourth currently in progress.

## 2026 Budget Approvals



- 2026 Trentview Estates Distribution System Budget



## WHERE DO YOUR *Tax* DOLLARS GO?



Of the Township's retained portion, 51% is allocated to essential services such as roads, policing, and fire protection.



**A 8.73% TAX RATE INCREASE IN 2026 EQUATES TO A \$13.29 INCREASE PER MONTH FOR THE AVERAGE HOMEOWNER\***

## Looking ahead: 2026 Projects



### ROADS & INFRASTRUCTURE

- Surface treatment (double tar-and-chip application) on Asphodel 7th Line and Asphodel 8th Line
- ~20,000 tonnes of gravel will be applied (three times the usual amount) to more than one-third of the gravel road network



### COMMUNITY CENTRE IMPROVEMENTS

- Replacement of one dehumidifier
- Splash Pad pump replacement



### MEDICAL CENTRE SUPPORT

- Continued support for the 17 Spruce Street Medical Centre to accommodate growth

In the fourth quarter, Council considered and/or made the following decisions:



Received Q3 2025 departmental reports



Adopted the third phase of the **Asset Management Plan**, achieving compliance with the July 1, 2025, requirements under O. Reg. 588/17



Council adopted the updated Procedural By-law (By-law 2025-53), which includes a change to the Council meeting location to the Town Hall. View [\*\*notice of adoption\*\*](#).



Approved the 2025 Water/Wastewater Study and Financial Plan for 2025-2035 in compliance with O. Reg. 453/07



Received a presentation on Invasive Phragmites and the Ontario Phragmites Action program



Received an update on the Township's application for Municipal Ice Storm Assistance Program funding related to the March 2026 ice storm



Set the **2026 Council Meeting Schedule** and Township Office closure dates



Approved the 2024 Consolidated **Financial Statements** of the Township of Asphodel-Norwood, as prepared by independent auditing firm, Baker Tilly



Council approved emergency shower access at the Asphodel-Norwood Fitness Centre during declared emergencies (e.g., Level 2 drought conditions or a State of Emergency), allowing residents to access shower facilities for a \$5 per person fee



Supported a 3% increase in Fitness Centre membership fees effective January 1, 2026



Approved a one-year extension with Circular Materials for continued Blue Box recycling services at the Transfer Station, implemented tipping fees (\$3 per blue box transaction and \$20 per cubic yard bulk) for non-eligible sources, and directed staff to report quarterly on impacts



Received an update on the Alto high-speed rail project, a Crown corporation initiative advancing a high-speed, electrified passenger rail network connecting Toronto, Peterborough, Ottawa, Montréal, Laval, Trois-Rivières, and Québec City



Received an **update** on the Community Safety & Well-being Plan.



Approved the 2026 Municipal Insurance Renewal proposal through Marsh Canada Ltd.



Adopted an updated Fees and Charges By-law, effective January 1, 2026, to better align municipal service rates with those of other Peterborough County municipalities, based on the County-wide average and rounded for ease of administration. Examples of updated fees include:

- Water meter fee: \$325 → \$425
- Tax certificate: \$40 → \$50
- 911 post and installation: \$100 → \$140
- Minor variance application: \$600 → \$1,500
- Zoning By-law amendment application: \$1,000 → \$1,900
