To seek relief from Section 5.2.1.(h) minimum front yard setback in the Township of Asphodel-Norwood Zoning By-law 2009-08, as amended.

1. Decrease the front yard setback of 6 metres (19.7') to 3.96 metres (13') to allow for the construction of a mud room addition.
